General Criteria for all Bursaries

- Bursaries are available to prospective students – boarding applicants are welcome to apply;
- Priority is given to children who are baptised Catholic, who may be attending a Catholic school and who are the sons of parents actively involved in a parish community;
- The bursary will cover a percentage of the academic tuition fee and/or boarding fee;
- Assessment will include completion of an Enrolment Application and Bursary Financial Assistance Form. External references are to be provided;
- Final approval for bursary support will be based on the outcome of an interview with either the Principal or Director of Campus at which the parent(s)/guardian(s) will also be present;
- The names of successful applicants remain confidential.

OXA Bursary

- This Bursary is available to prospective students entering Year 9 or Year 11;
- The Bursary will cover 100% of the tuition fees until Year 12;
- Prospective students must:
 - Demonstrate commitment to their Catholic faith;
 - Provide evidence that they have participated in community-based activities, such as sport, music and parish engagement;
 - Have a temperament that enables them to live positively in a community and contribute to its growth.
- Other criteria as outlined in the Enrolments Policy.
